None of the suggested alternatives were feasible. The Council discussed alternative solutions eg. Installing a Pelican Crossing, moving the crossing, extending the zigzag lines. The Clerk was asked to contact Transport for Bucks (TfB) to establish the cost and practicality of installing a Pelican crossing.</p> <p>Weight Restriction Horn St: Cllr Chambers reported on possible 'weight restrictions'/'unsuitable for heavy vehicles' sign locations. The Committee agreed to progress this option and asked the Clerk to quickly establish with TfB the cost and the process to install signs and make relevant changes to the road layout at the junction of Vicarage and Burleys Road to make it safe.</p> <p>Bus Stop near The Bell: The flags for the new stops near The Bell are in place.</p>
